

INDUSTRY INTERNSHIP PROGRAMME INTERN FAQ 2024



Programme Overview

The Industry Internship Programme is an initiative from the NZ Music Commission to help emerging music professionals and recent tertiary graduates gain experience and kick-start their careers in the music sector.

Interns are selected via an application process and offered a placement with a New Zealand music organisation or business that has applied to the Music Commission to host an Intern. Interns are mentored by their hosts and develop skills, knowledge and industry networks during their placement.

Running since 2018, the Industry Internship Programme has successfully placed Interns into a wide range of industry roles each year – including working in recording studios, events management, live music venues, PR and publishing companies, and plenty more.



The internship has helped achieve two things for me. Firstly, it's helped me get a foot in the door. I feel creative careers in New Zealand can be a bit challenging to get into, and having the internship has been an amazing opportunity to make connections. Secondly, it's given me the realisation the career that always seemed so far out of reach isn't a long shot of a goal - provided I'm willing to put in the hard work to achieve it.

Who can apply to be an Intern?

Anyone looking to develop their career in the music sector can apply to be an Intern, and we especially encourage emerging music professionals or recent tertiary graduates to apply.

If you have previously applied to be an Intern you are welcome to re-apply again! However, if you have already had a successful application to the Internship Programme, you cannot be selected for an internship for a second consecutive year.

NB: You will need to be a New Zealand citizen or resident to be eligible to apply.

Do Interns get paid?

Yes! Interns are paid the living wage of \$26.00 per hour before tax by the Music Commission.

What kind of roles are available?

Internship roles available each year depend on the Host Organisations taking part in the Programme.

In the past Interns have been placed in a wide variety of music sector positions, including working with record labels, music management, PR and events support, recording studio roles, film and television music supervision, and much more. The Music Commission invites Hosts to apply in the first instance, and the job titles of the available internships will be advertised when intern applications open.

When do Internships start, and how long do they run for?

While we try to be as flexible as possible, Internships are expected to start either in December 2023 or early 2024. All Internships must be completed before the end of June 2024. Internships are generally for 16 weeks, and can be part-time or full-time hours (depending on the needs of the Host Organisation).

How do I apply?

Intern application forms will be available on the *Resources* section of the Music Commission website, nzmusic.org.nz. Applicants will be shortlisted based on the information submitted in their cover letter, CV and intern application form – with priority given to those that show clear intentions and goals towards future music industry employment.
